Located in Nashville, Oasis Center is a nationally recognized organization on a mission to help young people in Middle Tennessee move into a happy, healthy, and productive adulthood.

In 1969, a group of young lawyers came together to establish the "Rap House," a simple community center for runaway teens and youth struggling with addictions. Nearly 50 years later,

the "Rap House" has evolved into Oasis Center, where over 3,000 youth and their families turn for help and direct support every year. Oasis Center provides a wide range of opportunities that reflect the diverse needs of youth and their families, from crisis intervention to youth leadership and community engagement to college and career access. Our 20+ programs and services are based on the foundation of four areas for youth success - Safety, Belonging, Empowerment, and Generosity. All

of our work is also firmly rooted in the evidence-

based principles of Positive Youth Development and Trauma-Informed Care.

Youth Engagement & Action programs include the Bike Workshop, Building Bridges, International Teen Outreach Program (ITOP), Just Us, Maptivists, Mayor's Youth Council, Oasis Transitions, The REAL Program, Statewide TOP, Underground Art Studio, and WeGo Transit Youth Action Team.

Our YEA programs provide young people with leadership opportunities, life skills development, and meaningful community engagement experiences. Each program is designed to build a positive sense of self and allow freedom to express individuality as youth learn to channel their passion and become advocates for their future.

With the onset of the pandemic, the Spring of 2020 marked the need to completely reimagine what it means to support our youth. To ensure the safety of our youth as well as follow CDC and local COVID guidelines, many of our YEA programs

switched to virtual programming. As we continue to navigate this global health crisis, we are thankful for the resilience and creativity of our staff, partners, and young people.

- Just Us engaged 88 youth in weekly empowerment meetings, provided counseling to 46 youth and 36 family members, and provided training to nearly 500 youth providers!

This year, the **Mayor's Youth Council (MYC)** planned, coordinated, and facilitated the annual Mayor's Youth Summit in a virtual environment for the first time -- **190** youth and community leaders came together to discuss student-identified topics.

Crisis-to-Housing services represent a spectrum of programs and services exclusively for youth who are experiencing homelessness, have run away, and/or are experiencing familial crisis to the brink of family fracture. The COVID crisis has added an enormous burden on our youth. Through it all, our Crisis-to-Housing team continued to provide much needed services to youth most in need.

Runaway and youth-in-crisis and their families were provided a safe place to turn with our Emergency Shelter.

Youth (ages 18-24) experiencing homelessness were provided basic needs and case management.


